OBJECTIVES:

MAINTAIN THE STANDARDS OF AN NCQA-RECOGNIZED PATIENT CENTERED MEDICAL HOME THAT HAVE BEEN PROVEN TO RESULT IN IMPROVED CLINICAL OUTCOMES AND THE REDUCTION OF UNNECESSARY COSTS.

AT LEAST 90% OF PATIENTS WILL HAVE A DECREASE DUE TO ILLNESS IN LIMITATIONS AS MEASURED BY THE SOCIAL/ROLE ACTIVITIES LIMITATIONS INSTRUMENT FROM THE STANFORD PATIENT EDUCATION RESEARCH CENTER.

CONTINUE TO WORK WITH LOCAL HOSPITAL PARTNERS TO BRING ABOUT A DEMONSTRATED REDUCTION IN INAPPROPRIATE ED UTILIZATION BY NCH PATIENTS. ED UTILIZATION WILL BE EVALUATED MONTHLY AND THE GOAL IS A REDUCTION OVER TIME FROM THE CURRENT LEVEL ON A PATIENT-BY-PATIENT BASIS.

BY END OF 2015, OUR ADHERENCE TO CLINICAL CARE STANDARDS AND OUR PATIENTS' CLINICAL OUTCOMES WILL COMPARE FAVORABLY WITH ALL OTHER PRACTICES PARTICIPATING IN BETTER HEALTH GREATER CLEVELAND, A REGIONAL COLLABORATIVE FOCUSED ON IMPROVING THE QUALITY OF PRIMARY CARE. SPECIFICALLY:
